- the candidates who got re-appear/failure in HSP-I (11th Class) CCE Scheme , Session Bi-annual,2018, Private/Backlog of (Summer Zone)
- and to protect the academic career, the Chairman BoSE has granted **mercy chance** to those candidates who appeared in of CCE Scheme, in previously conducted examinations falling under Winter Zone areas.

As such, the schedule for submission of the enrollments/Micro-packing Statements by the Government/Private affiliated Institutions of the Jammu Province (Summer/Winter Zone) including Leh for the eligible Private candidates of Higher Secondary Part-I (Class 11th) Term-I and Term-II (**Mercy Chance for the candidates of Winter Zone area**) for Session Bi-annual 2018-19 and last date for the candidates of Summer Zone also is notified as under:-

1. Eligibility :-

- Candidates having backlog (Re-appear/Failure) in Hr. Secondary Part-I (Under CCE Scheme) Examination conducted through Govt./Private affiliated academic institutions of Jammu and Kashmir (BOSE)

2. Instruction and Guidelines for Deposition of Enrollments/Fee

- The fee, as prescribed above shall be deposited by the Heads of the affiliated institutions in shape of bank slip to be obtained from the concerned BOSE office, and deposited in the designated branches of the Jammu and Kashmir Bank.
- The Heads of the Affiliated institutions are instructed to submit the Enrollment/Micro-Pack statements along-with forwarding letters in the respective Sub/Branch Offices and Examination Unit-II BOSE, JD through their authorized Representatives. The letters must indicate the (Subject-wise) number of candidates enrolled and description of the fee deposited in the Bank.

NOTE :- In case the last date of submission of Micro packing/Fee falls on Sunday/ holiday , the next working day shall be treated as last date.
