

General Instructions regarding eligibility for Migration to J&K BOSE:

- Students having qualified 9th/10th/11th or its equivalent examination through CBSE or any other recognized University/ Board of the country.
- Session of study coincides with the study session of the J&K BOSE, Kashmir Division.
- Admission of a candidate to next higher class (Secondary/ Higher Secondary) shall be subject to declaration of the result of previous class, by the respective Universities/ Boards of the country, by or before 31st March,2021.
- It shall be mandatory to pass/ complete Class 9th/ 10 and Class 11th/12th in two academic sessions.
- Candidates placed in Re-appear/ Compartment category in any of the opted subjects by CBSE or any other recognized University/ Board of the country are not eligible to seek admission in Regular capacity in next higher class in any Affiliated Academic Institution of the J&K BOSE, Kashmir Division. Such candidates, if desire to appear afresh in the same class, i.e., Class 10th,11th or 12th, as the case may be, through this Board shall be allowed to do so in Private capacity only, subject to fulfillment of other formalities laid down in the regulations.

The last dates notified above shall be final and no claim, whatsoever, shall be accepted after the expiry of the above notified last date.
